BYLAW NO. 201

TAXATION BYLAW 2021

A bylaw for imposing taxes upon lands in the improvement district and to provide for imposing a percentage addition to encourage prompt payment thereof.

The Trustees of Kemp Lake Waterworks District ENACT AS FOLLOWS:

1. For the year 2021, there are hereby levied the following taxes:

- 1) A tax of \$455.00 on all parcels of land classified into Group 1
- 2) A tax of \$910.00 on all parcels of land classified into Group 2.
- 3) A tax of \$1,365.00 on all parcels of land classified into Group 3.
- 4) A tax of \$1,820.00 on all parcels of land classified into Group 4.
- 5) A tax of \$6,825.00 on all parcels of land classified into Group 5.
- 6) A tax of \$14,560.00 on all parcels of land classified into Group 6.
- 7) A tax of \$49,595.00 on all parcels of land classified into Group 7.
- 8) A tax of \$500.00 on all parcels of land classified into Group 8.
- 9) A tax of \$1,000.00 on all parcels of land classified into Group 9.
- 10) A tax of \$535.00 on all parcels of land classified into Group 10.
- 11) A tax of \$1,070.00 on all parcels of land classified into Group 11.
- 12) A tax of \$420.00 on all parcels of land classified into Group 12.
- 13) A tax of \$0.00 on all parcels of land classified into Group 13.
- 14) A tax of \$535.00 on all parcels of land classified into Group 14.
- 15) A tax of \$2,275.00 on all parcels of land classified into Group 15.
- 2. The aforementioned taxes are due and payable on or before the THIRTY-FIRST day of OCTOBER, 2021, and will have a percentage addition of 10 per cent added to all taxes remaining unpaid after the said date.
- 3. In addition, taxes remaining unpaid on the 1st day of March next following the date upon which the taxes are levied will bear interest at the rate prescribed by the Lieutenant Governor in Council under the Taxation (Rural Area) Act, as set out under Section 760 of the Local Government Act.

4. This bylaw may be cited as the new "Taxation Bylaw, 2021".
