By-Law No. 206

TAXATION CATCHUP BYLAW 2022

A by-law for imposing taxes upon lands in the improvement district and to provide for imposing a percentage addition to encourage prompt payment thereof.

The Trustees of the Kemp Lake Waterworks District ENACT AS FOLLOWS:

1. For the year 2022, there are hereby levied the following taxes:

1

- 1) A tax of \$425.00 on all parcels of land classified into Group 1
- 2) A tax of \$850.00 on all parcels of land classified into Group 2.
- 3) A tax of \$1,275.00 on all parcels of land classified into Group 3.
- 4) A tax of \$1,700.00 on all parcels of land classified into Group 4.
- 5) A tax of \$6,375.00 on all parcels of land classified into Group 5.
- 6) A tax of \$13,600.00 on all parcels of land classified into Group 6.
- 7) A tax of \$46,325.00 on all parcels of land classified into Group 7.
- 8) A tax of \$470.00 on all parcels of land classified into Group 8.
- 9) A tax of \$940.00 on all parcels of land classified into Group 9.
- 10) A tax of \$505.00 on all parcels of land classified into Group 10.
- 11) A tax of \$1,010.00 on all parcels of land classified into Group 11.
- 12) A tax of \$390.00 on all parcels of land classified into Group 12.
- 13) A tax of \$0.00 on all parcels of land classified into Group 13.
- 14) A tax of \$505.00 on all parcels of land classified into Group 14.
- 15) A tax of \$2,125.00 on all parcels of land classified into Group 15.
- 2. The aforementioned taxes shall be due and payable on or before the THIRTY-FIRST day of OCTOBER, 2023 and any portion remaining unpaid after this date shall have a percentage addition of 10 per cent added thereto.
- 3. All payments made on taxes levied or purported to have been levied for the 2022 shall be credited as payment against the taxes levied and/or the percentage additions added in Clause 1 and 2 above.

- 4. In addition, taxes remaining unpaid on the 1st day of March next following the date upon which the taxes are levied shall bear interest at the rate prescribed by the Lieutenant-Governor in Council under the *Taxation (Rural Area) Act*, as set out under Section 717 of the Local *Government Act*.
- 5. This by-law may be cited as the "Taxation Catchup Bylaw 2022".
